# Other Family Trees – MARRIS of Newark & Barton

#### First Generation

#### 1. Unknown Marris.

This is one of a number of MARRIS trees that has not been connected into the main Marris pedigree published on www.marrisfamilyhistory.uk.

This line is part of the Marris pedigree accepted by the College of Arms in 1940. It was afterwards published in the 1952 edition of Burke's Landed Gentry (see "Winston-Davis-De Marris of Pattyndenne Manor" in that edition). According to the pedigree, the Marris family of Newark upon Trent descends from John Marris & Agnes Bell of South Carlton, Lincs, as shown in this brief outline:

- John Marris (d.1552) & Agnes Bell of South Carlton, Lincs
  - Robert Marris (d.1591) & Alice Anderson of Grasby, Lincs
    - Thomas Marris (1554-1609) & Agnes Cordwyn of Grasby
      - Robert Marris (1585-1657) & Barbara Leach of Grasby
        - John Marris (1616-78) & Mary Jecks of Newark upon Trent, Notts
          - Robert Marris (1635-1715) & Anne Thompson of Newark upon Trent

The line going back to the above Robert Marris (m. Anne Thompson) and Robert's father John Marris is well established (see below). But, rather than Mary Jecks, it would appear that John Marris (1616-78) married:

- 1) Isabelle Brownley on 26 Jun 1628 at Newark upon Trent, Notts
- 2) Isabell Standley on 22 Oct 1631 at Newark upon Trent, Notts
- 3) Sarah [only her Christian name known]

Also, whereas Burke's refers to John Marris (1616-78), I found him to have been buried on 20 Feb 1653/54 (and with no sign of when he was actually born).

The next difficulty comes with the parents of this thrice-married John Marris. Burke's gives his parents as Robert Marris (1585-1657) & Barbara Leach of Grasby (as above). But according to the Barker Papers at the Sheffield Archives (Ref: Bar D), this line in fact descends from Colonel John Marris (often spelt Morris) who seized Pontefract Castle on behalf of King Charles I in 1648 and, after his capture, was executed by the Parliamentarians in 1649. A pedigree of the Colonel's line will be found in Dugdale's Visitation of Yorkshire (under "Morris of North Emsall") and also on p.1703 of Burke's Landed Gentry (1952).

The Barker Papers (see Bar D. 828) include a transcription of a letter from Colonel John Marris to Colonel Charles Fairfax, with Fairfax's reply, concerning an exchange of prisoners. The papers say that the original letters (framed) are still with the Barker family. They also say that "Thomas Barker (1709 – 1754) married in 1729 a descendant of Colonel Morris".

The Thomas Barker referred to was Steward for the Duke of Rutland who married Sarah Marris (bapt. 7 Jun 1705 at Newark on Trent, Notts). Sarah was the daughter of Joseph Marris & Mary née Lillie (see below). If she (Sarah) was in possession of the executed Colonel's original papers, it is reasonable to accept that she descended from him. The tree shown here starts with "Unknown" because their exact relationship has yet to be determined.

#### Unknown had the following children:

- + 2 M i. **John Marris** was buried on 20 Feb 1653/1654.
- + 3 M ii. William Marris.

#### Second Generation

2. John Marris (Unknown) was buried on 20 Feb 1653/1654 in Newark upon Trent, Notts.

It is presumably this John Marris who lent £10 "unto His Majesty's Commissioners here in the Siege of this town, begun 29th February 1643(4)" and who resigned as Alderman of the town in 1650 (Ref: History of Newark).

The Newark Burial Register refers to him as "Mr John Morris". In Newark, the surnames Morris and Marris seem to have been interchangeable in many instances. The term "Mr" suggests that John was a gentleman. He made his will on 17 Feb 1653/54 and it was proved 8 May 1654 (Ref: PRO Wills 1654 Prob 11, 242, Quire 477). In the will, he gives his occupation as Tanner and names his wife Sarah, eldest son John (executor), younger son Robert (not yet 21), Elizabeth Somers (eldest daughter), Thomas Somers (her husband), <unnamed> Padgett, also a daughter and her husband Edward Padgett. The will also names John's brother William.

There is an (unproven) indication of a family relationship with Fitch. The above will says "I give unto her my said wife also Fortie poundes which was hers before our marriage and is yet in the hands of John Fitch of Market Raison in the Countie of Lincolne".

John married (1) **Isabelle Brownley** on 26 Jun 1628 in Newark upon Trent, Notts. Isabelle was buried on 18 May 1629 in Newark upon Trent, Notts.

The Barker Papers at the Sheffield Archives (Ref: Bar.D.828) contain a transcription of some entries found in the Newark upon Trent PRs (the transcription was made in 1902). Among the entries is:

1629, May 18, Bur Essabell Morris, wife of John.

John married (2) **Isabell Standley** on 22 Oct 1631 in Newark upon Trent, Notts.

The Barker Papers at the Sheffield Archives (Ref: Bar.D.828) contain a transcription of some entries found in the Newark upon Trent PRs (the transcription was made in 1902). Among the entries is:

1640, Sep 8, Issabell Morris Buryed.

One cannot tell if this is referring to the mother or the daughter. If the mother, then those children (below) baptised later than 1640 were presumably those of John's third wife Sarah.

John and Isabell had the following children:

4 F i. **Isabel Marris** was christened on 1 Sep 1632 in Newark upon Trent, Notts.

Isabell's baptism appears in the Newark Baptism Register. We know from her father's will that one of this generation married Edward Padgett. The assumption is that it was Isabel whom Edward Padgett married.

Isabel married Edward Padgett.

- + 5 M ii. **John Marris** was christened on 4 Sep 1634. He was buried on 3 Apr 1688.
- + 6 M iii. **Robert Marris** was christened on 31 Jan 1636/1637. He was buried on 15 Sep 1715.
  - 7 F iv. Elizabeth Marris.

Elizabeth married Thomas Somers.

At the Nottinghamshire Archives, a deposit of papers from "Tallents and Company of Newark, solicitors [DD/T/1 - DD/T/80]" contains a copy of the will of Thomas Summers of Newark, woollen draper - ref. DD/T/45/25 - date: 1705. According to http://www.a2a.org.uk, the will says:

"To cousin Robert Marris, tanner, remission of debt of £60 on bond, and to pay not over 5 per cent on rest of his debt".

8 Fv. Bridgett Marris was christened on 27 Aug 1639 in Newark upon Trent,Notts. She was buried on 12 Aug 1647 in Newark upon Trent, Notts.

The Barker Papers at the Sheffield Archives (Ref: Bar.D.828) contain a transcription of some entries found in the Newark upon Trent PRs (the transcription was made in 1902). Among the entries is:

1639, Aug 27, Bridgett Morris the dau of John and Issabell his wife baptized.1647, Aug 12, Briget Morris dau of John Buried.

John married (3) Sarah.

## 3. William Marris (Unknown).

William married **Isabell**. Isabell was buried on 24 Nov 1657 in Newark upon Trent, Notts.

They had the following children:

9 F i. **Bettatay Bellalay(?) Marris** was buried on 4 Jun 1642 in Newark upon Trent, Notts.

The Barker Papers at the Sheffield Archives (Ref: Bar.D.828) contain a transcription of some entries found in the Newark upon Trent PRs (the transcription was made in 1902). Among the entries is:

1642, June 4, Bettatay/Bellalay(?) Morris dau of Willm Buried.

10 M ii. **John Marris** was buried on 13 Jun 1642 in Newark upon Trent, Notts.

The Barker Papers at the Sheffield Archives (Ref: Bar.D.828) contain a transcription of some entries found in the Newark upon Trent PRs (the transcription was made in 1902). Among the entries is:

1642, June 13, John Morris sonne of Wm Buried.

#### **Third Generation**

5. **John Marris** (John, Unknown) was christened on 4 Sep 1634 in Newark upon Trent, Notts. He was buried on 3 Apr 1688 in Newark upon Trent, Notts.

John Marris was Mayor of Newark in 1669 and again in 1681. The Newark Burial Register describes him as "Mr John Marris Alderman". He made his will on 30 ??? 1688, giving his occupation as Tanner. He named his brother Robert Marris, Woollen Draper and his wife Arabella. The Bond for Probate of his will says that the executor was Robert Marris, his brother.

John married **Arabella**. Arabella was buried on 19 Jan 1697/1698 in Newark upon Trent, Notts.

The Newark Burial Register refers to her as "Mrs Arabella Marris widow". There is a document that shows her withdrawing on 18 May 1688 from the executorship of the will of her late husband, John Marris, Alderman, "whose will was dated? Nov last past". She withdrew, allowing Robert Marris, Woollen Draper of Newark, Gent, to be sole executor.

John and Arabella had the following children:

11 M i. **William Marris** was christened on 19 Aug 1658 in Newark upon Trent, Notts. He was buried on 25 Sep 1658 in Newark upon Trent, Notts.

The Barker Papers at the Sheffield Archives (Ref: Bar.D.828) contain a transcription of some entries found in the Newark upon Trent PRs (the transcription was made in 1902). Among the entries is:

1658, Aug 19, William sonne of Mr John Morris bapt.

The Newark Burial Register shows William's burial and refers to his father as "Mr John Morris".

ii. Arabella Marris was christened on 21 Nov 1659 in Newark upon Trent,Notts. She was buried on 11 Sep 1677 in Newark upon Trent, Notts.

In the Newark Baptism Register, her father is referred to as "Mr John Morris".

The Barker Papers at the Sheffield Archives (Ref: Bar.D.828) contain a transcription of some entries found in the Newark upon Trent PRs (the transcription was made in 1902). Among the entries is:

- 13 F iii. **Elizabeth Marris** was christened on 17 Aug 1661 in Newark upon Trent, Notts. She was buried on 25 Jan 1680/1681 in Newark upon Trent, Notts.
- 14 M iv. John Marris was christened on 10 Oct 1664 in Newark upon Trent, Notts. He was buried on 23 Jun 1670 in Newark upon Trent, Notts.

The Barker Papers at the Sheffield Archives (Ref: Bar.D.828) contain a transcription of some entries found in the Newark upon Trent PRs (the transcription was made in 1902). Among the entries is:

1670, June 23, Bur John Morris son of John.

- + 15 M v. **Robert Marris** was christened on 24 Nov 1666. He was buried on 25 Aug 1741.
  - 16 F vi. **Jane Marris** was christened on 14 May 1672 in Newark upon Trent, Notts.
  - Robert Marris (John, Unknown) was christened on 31 Jan 1636/1637 in Newark upon Trent, Notts. He was buried on 15 Sep 1715 in Newark upon Trent, Notts.

Robert Marris was Mayor of Newark in 1675, 1687, 1700 and 1709. The Roman Catholic King James II issued an order on 24th February 1687 removing Robert Marris from being Mayor of Newark.

Vol 14 of "Transactions of the Thoroton Society" (Ref: NT/PER at the Society of Genealogists) mentions the following:

"The largest piece [of corporation and church plate and insignia on display at Barnby Gate House] is the tall standing cup and cover of silver gilt, the cup alone  $2\frac{1}{2}$  ft high, bearing the London Hall-mark for 1686-7 and inscribed Donum Honorab: Henrici Savile Arm: An: Dn: 1687, Robert Marris, Majore. It is in this cup that the Mayor pledges his guests on returning to the Town Hall after the state attendance at church on "Mayor's Sunday"."

Robert Marris made his will on 27 August 1715 and it was proved 28 February 1715/16 (Ref: York Prerog & Escheq Vol 70, Folio 355). He gives his occupation as Woollen Draper and names his late wife Ann, Eldest son John, second son Joseph, youngest son Robert, eldest daughter Mary Marris,

second daughter Sarah Wilkinson and youngest daughter & executrix Constance. Also named are his Aunt Wilmot, grandsons Robert & Thomas (the sons of Robert), grand-daughters Mary, Ann, Sarah and Elizabeth (the daughters of Joseph), daughter-in-law Mary Marris (nee Lillie) and some other people of unspecified relationship.

The Newark Burial Register refers to him as "Mr Robert Marris senior".

The family papers of Harold Colquhoun Marris OBE (1883-1966) refer to an account, written in 1893, of an armorial window originally erected at Newark and, around 1760, removed to a house owned by the family at Barton upon Humber (in Priestgate, in the parish of St Peter). The painted glass consists of two elliptical, and six circular, plates, amber coloured. One plate contains the Marris arms and motto "Tout Pour L'Eglise". Another plate says:

R & A M, 1698 (i.e. Robert & Ann Marris) have issue three sonnes and three daughters: John married to Mrs Sarah Atkinson have issue Sarah & Anne Joseph

Robert married **Anne Thompson** on 1 Jan 1660/1661 in Newark upon Trent, Notts. Anne was buried on 20 Dec 1709 in Newark upon Trent, Notts.

The Newark Burial Register confirms that Anne was "wife of Mr Robert Marris".

Robert and Anne had the following children:

- i. Constance Marris was christened on 12 Oct 1661 in Newark upon Trent, Notts. She was buried on 28 Jul 1662 in Newark upon Trent, Notts.
- + 18 M ii. **John Marris** was christened on 26 Jan 1663/1664. He was buried on 17 Feb 1727/1728.
  - 19 F iii. **Anne Marris** was christened on 7 Mar 1664/1665 in Newark upon Trent, Notts.
  - 20 F iv. Mary Marris was christened on 14 May 1666 in Newark upon Trent, Notts.

 V. Sarah Marris was christened on 24 Mar 1667/1668 in Newark upon Trent, Notts. She died on 19 Feb 1745 in Stamford, Lincs.
 Sarah married Zachariah Wilkinson . Zachariah died before 17 Apr 1744.

Sarah Wilkinson made her will (LCC Wills 1745/146) on 17 April 1744 and it was proved 8 March 1745/46. In her will, Sarah describes herself as a widow, of Stamford, Lincs. She names in her will the following people:

- her late husband Zachariah Wilkinson
- her brother & executor Robert Marris, surgeon of Barton upon Humber and his wife Jane.
- her niece Ann Marris, the daughter of her brother John Marris deceased
- her nephew Thomas Marris of Barton
- Thomas Barker of Bakewell, Derbys, and his wife Sarah (who was her niece)
- her niece Elizabeth Marris, the daughter of her brother Joseph Marris deceased
- Sarah Clarke, the daughter of her niece Mary Clarke deceased
- Mary Smith, the daughter of her niece Ann Smith deceased
- her cousin Ann Wilmot of London, Milliner.
- 22 M vi. Robert Marris was christened on 1 Apr 1669 in Newark upon Trent, Notts. He was buried on 21 May 1674 in Newark upon Trent, Notts.
- 23 F vii. **Elizabeth Marris** was christened on 4 Aug 1670 in Newark upon Trent, Notts. She was buried on 21 Nov 1670 in Newark upon Trent, Notts.
- 24 F viii. **Constance Marris** was christened on 29 Oct 1672 in Newark upon Trent, Notts.

Constance Marris is named in an Obligation dated 19 October 1715. It names her as Executrix of the will of Robert marris of Newark. The obligation is signed by Constance marris, Joseph Marris and Mary Marris.

- + 25 M ix. **Joseph Marris** was christened on 30 Mar 1673/1674.
  - 26 M x. William Marris was christened on 2 Nov 1675 in Newark upon Trent, Notts. He was buried on 29 Jan 1675/1676 in Newark upon Trent, Notts.

- + 27 M xi. **Robert Marris** was christened on 3 Apr 1677. He was buried on 4 Oct 1753.
  - 28 F xii. **Elizabeth Marris** was christened on 15 Nov 1678 in Newark upon Trent, Notts. She was buried on 30 May 1679 in Newark upon Trent, Notts.

The Barker Papers at the Sheffield Archives (Ref: Bar.D.828) contain a transcription of some entries found in the Newark upon Trent PRs (the transcription was made in 1902). Among the entries is:

1679, May 30, Bur Eliz dau of Robert Marris.

29 F xiii. **Anne Marris** was christened on 12 May 1681 in Newark upon Trent, Notts. She was buried on 27 Jan 1682/1683 in Newark upon Trent, Notts.

The Barker Papers at the Sheffield Archives (Ref: Bar.D.828) contain a transcription of some entries found in the Newark upon Trent PRs (the transcription was made in 1902). Among the entries is:

1681 May 12, Bap Ann dau of Robert Marris 1682/3 Jan 27, Bur Anne dau of Mr Robert Marris Alderman.

#### **Fourth Generation**

15. **Robert Marris** (John, John, Unknown) was christened on 24 Nov 1666 in Newark upon Trent, Notts. He was buried on 25 Aug 1741 in Newark upon Trent, Notts.

Robert married Ruth Bullis on 20 Jun 1710 in Newark upon Trent, Notts.

It is worth demonstrating the proof that it was this Robert (son of John) who married Ruth Bullis rather than the Robert baptised 3 April 1677 (son of Robert who married Ann Thompson).

A marriage licence (Ref: BRS/58 Vol 2 at the Society of Genealogists) reads as follows:

20 Jun 1710 - Robert Morrice of Newark-on-Trent, tanner, bac., 36, & Ruth Bullis, of Newark, 26, spr.,at Burton Joyce or Shelford.

There is an obvious age discrepancy if Robert was 36 at the time of his marriage as that would make his year of birth 1673/4. However, the signature of Robert on the actual licence is identical to the signature on a pre-nuptial settlement document described below (Ref: Bar.D.570) which describes him as "Robert Marris the Younger of Newark, Nephew of Robert Marris the Elder, Woollen Draper".

The marriage licence describes Robert as a bachelor, and a tanner of Newark. Ruth is described as a spinster of Newark. In the Newark Baptism Register, at the baptisms of his first two children, Robert and John, he is described as "Mr Robert Marris". At the baptism of his third son, Thomas, he is described as "Mr Robert Marris Taner (sic)". When Mary is baptised, he is described as "Mr Robert M?rris Alderman".

The Barker Papers at the Sheffield Archives contain documents referring to Joseph Marris and his intended bride Mary Lillie. These documents – Bar.D.286 (1 Oct 1701) and Bar.D.287 (2 Oct 1701) – concern a pre-nuptial settlement which names, among others, various members of the Lillie family and Robert Marris the Younger of Newark, Tanner. Joseph Marris is described as of Newark, one of the sons of Robert Marris the Elder of Newark, Woollen Draper. The intended bride, Mary Lillie, is described as spinster, the eldest daughter of John Lillie and Mary Lillie the Elder.

Another pre-nuptial settlement document, also dated 2 Oct 1701 (Ref: Bar.D.570) again mentions "Robert Marris the Elder of Newark, Woollen Draper" but this time describes the younger Robert as "Robert Marris the Younger of Newark, Nephew of Robert Marris the Elder".

One assumes also that it is this Robert Marris who was Mayor of Newark in 1722 and 1735. One also assumes it is this Robert who made his will on 8 Sept 1741, and which was proved 9 Feb 1743. He describes himself as a Tanner of Newark and names two of his children: William and Mary.

The Barker Papers at the Sheffield Archives (Ref: Bar.D.828) contain a transcription of some entries found in the Newark upon Trent PRs (the transcription was made in 1902). Among the entries is:

1741 Aug 25, Bur Robert Morris Alderman. 1728, May 13, Bur Rebeccah wife of Aldm Maris.

Was Rebecca the second wife of the above Robert perhaps?

Robert and Ruth had the following children:

 Robert Marris was christened on 13 Nov 1710 in Newark upon Trent, Notts.

Robert Marris and his sister Mary Marris are named in an indenture dated 8 Nov 1746 (Ref: FH1155 at the Northants Record Office). The indenture is between Mary Marris, spinster, daughter and executrix of the last will and testament of Robert Marris of Newark, Tanner, Robert Marris, eldest son & heir at law of said Robert and someone called Samuel Gordon of Newark.

- + 31 M ii. **John Marris** was christened on 14 Aug 1712. He was buried on 21 Oct 1783.
  - 32 M iii. **Thomas Marris** was christened on 7 Jan 1713/1714 in Newark upon Trent, Notts.
  - 33 F iv. **Mary Marris** was christened on 19 Jul 1716 in Newark upon Trent, Notts.

As mentioned above, Robert Marris and his sister Mary Marris are named in an indenture dated 8 Nov 1746 (Ref: FH1155 at the Northants Record Office). The indenture is between Mary Marris, spinster, daughter and executrix of the last will and testament of Robert Marris of Newark, Tanner, Robert Marris, eldest son & heir at law of said Robert and someone called Samuel Gordon of Newark.

- 34 M v. **William Marris** was christened on 23 Jan 1718/1719 in Newark upon Trent, Notts.
- 18. **John Marris** (Robert, John, Unknown) was christened on 26 Jan 1663/1664 in Newark upon Trent, Notts. He was buried on 17 Feb 1727/1728 in Newark upon Trent, Notts.

John married **Sarah Atkinson** on 20 Jun 1694 in Newark upon Trent, Notts. Sarah was buried on 17 Feb 1739/1740 in Newark upon Trent, Notts.

The marriage licence (Ref: BRS/58 Vol 1 at the Society of Genealogists) reads as follows:

20 Jun 1694 - John Morris (signed Marris) of Newark on Trent, cloathier & Sarah Atkinson, of same, spr.,

[Bond by Robert Morris (signed Marris) of same, alderman].

Curiously, Sarah is described as a spinster on the marriage licence but as "Mrs Sarah Atkinson" in the actual marriage entry in the Newark PRs.

In the Newark Baptism Register, John is described as "Mr John Morris" at the baptism of each of his four children.

He was dead by the time his sister Sarah Wilkinson made her will on 17 April 1744.

The Barker Papers at the Sheffield Archives (Ref: Bar.D.828) contain a transcription of some entries found in the Newark upon Trent PRs (the transcription was made in 1902). Among the entries is:

1727/28 Feb 17, Bur John Morris.1739/40 Feb 17, Bur Sarah Morris, Widow.

One assumes the above entry refers to this Sarah (nee Atkinson).

John and Sarah had the following children:

i. Sarah Marris was christened on 28 Nov 1695 in Newark upon Trent,Notts. She was buried on 10 Aug 1724 in Newark upon Trent, Notts.

The Barker Papers at the Sheffield Archives (Ref: Bar.D.828) contain a transcription of some entries found in the Newark upon Trent PRs (the transcription was made in 1902). Among the entries is:

1724, Aug 10, Bur Sarah dau of Mr John Morris.

One assumes that the entry refers to this Sarah.

36 M ii. **Robert Marris** was christened on 22 Oct 1696 in Newark upon Trent, Notts. He was buried on 23 Nov 1696 in Newark upon Trent, Notts.

The Newark Burial Register records the father as "Mr John Marris".

- 37 F iii. **Anne Marris** was christened on 21 Jun 1698 in Newark upon Trent, Notts.
- 38 F iv. **Elizabeth Marris** was christened on 15 Aug 1699 in Newark upon Trent, Notts.
- 25. **Joseph Marris** (Robert, John, Unknown) was christened on 30 Mar 1673/1674 in Newark upon Trent, Notts.

#### Joseph married Mary Lillie.

The Barker Papers at the Sheffield Archives contain documents referring to Joseph Marris and his intended bride Mary Lillie. Bar.D.286 (1 Oct 1701) and Bar.D.287 (2 Oct 1701) concern a pre-nuptial settlement which names, among others, various members of the Lillie family and Robert Marris the Younger of Newark, Tanner. Joseph Marris is described as of Newark, one of the sons of Robert Marris the Elder of Newark, Woollen Draper. The intended bride, Mary Lillie, is described as spinster, the eldest daughter of John Lillie and Mary Lillie the Elder.

Bar.D.592 (2 Mar 1702) names the same people as above though, by now, Joseph Marris and Mary Lillie are married. Although the date and place of the marriage have not been found, we can deduce that the marriage took place sometime between 2 Oct 1701 and 2 March 1702. This document clarifies that Robert Marris, Tanner, was the nephew (rather than son) of Robert Marris, woollen Draper, father of Joseph. In other words, Joseph Marris and Robert Marris, Tanner, were cousins rather than brothers.

An indenture (Ref: Bar.D.288) dated 5 May 1712 concerning the release of interest on the manor of "Raynethorpe als Raventhorpe" gives Joseph's occupation as Woollen Draper and names his wife as Mary. Again, various members of the Lillie family are named.

The family papers of Harold Colquhoun Marris OBE (1883-1966) contain a note of a PCC Admon (1718, p.76) concerning the death of Joseph Marris, late master of the ship Triumph who, with his wife and family, were drowned at the foundering of the ship. On 10 May 1718, administration was granted to Robert Marris, his lawful brother. Burke's Landed Gentry (1952) says that it was this Joseph. However, this hardly seems likely as Joseph of Newark was a Woollen Draper, not the master of a ship.

Joseph and Mary had the following children:

i. Mary Marris was christened on 22 Oct 1702 in Newark upon Trent,
 Notts.

Mary Marris was a spinster who lived at Bakewell, Derbys. She made her will (Ref: Bar.D.696 at the Sheffield Archives) on 18 October 1764 and it was proved on 24 April 1769. The will names her sister Sarah Barker, widow (appointed executrix) and niece Mary (wife of Mr Buckbury of Billingsborough, Lincs, Husbandman). Mary's name is written as Morris in the will; and she signs as Morris. Witnesses were Elizabeth Lillie and Richard Webster Junior.

40 F ii. **Anne Marris** was christened on 25 Oct 1703 in Newark upon Trent, Notts.

Anne married **Richard Smith** on 5 Feb 1732/1733 in Newark upon Trent, Notts.

A marriage licence (Ref: BRS/58 Vol 2 at the Society of Genealogists) reads as follows:

5 Feb 1732-33 - Richard Smith of Billingborough, co. Linc., bac., 25, & Ann Morris of Newark, spr., 29, at Mansfield.

41 F iii. **Sarah Marris** was christened on 7 Jun 1705 in Newark upon Trent, Notts.

It was this Sarah Marris whom the Barker Papers at the Sheffield Archives describe as a descendant of Colonel John Marris (often spelt Morris) who seized Pontefract Castle for King Charles I and, after capture by the Parliamentarians, was executed in 1649.

Sarah married **Thomas Barker** . Thomas was buried on 7 Nov 1764 in Bakewell, Derbys.

Thomas Barker was Steward for the Duke of Rutland.

42 F iv. **Elizabeth Marris** was christened on 16 Oct 1707 in Newark upon Trent, Notts.

v. Jane Marris was christened on 13 Jul 1710 in Newark upon Trent,
 Notts. She was buried on 20 Feb 1710/1711 in Newark upon Trent,
 Notts.

The Newark Burial Register refers to her as "Jane Marris a child".

27. **Robert Marris** (Robert, John, Unknown) was christened on 3 Apr 1677 in Newark upon Trent, Notts. He was buried on 4 Oct 1753 in Barton upon Humber, Lincs.

Robert married **Jane Legard**. Jane was buried on 28 May 1753 in Barton upon Humber, Lincs.

They had the following children:

44 M i. **Robert Marris** was buried on 3 Jan 1734/1735 in Barton upon Humber, Lincs.

The Barton burial register describes him as Robt. Marris Jnr.

+ 45 M ii. **Thomas Marris** was born about 1704/1705. He died on 19 Dec 1797.

## Fifth Generation

31. **John Marris** (Robert, John, John, Unknown) was christened on 14 Aug 1712 in Newark upon Trent, Notts. He was buried on 21 Oct 1783 in Newark upon Trent, Notts.

John married **Elizabeth Clay** on 8 Oct 1739 in Newark upon Trent, Notts. Elizabeth was buried on 25 Oct 1785 in Newark upon Trent, Notts.

There is a will (Ref: PRNW at the Notts Record Office) of a John Marris, Feltmonger, of Newark upon Trent. It looks like the will of this particular John (though some additional evidence would be useful). The will is dated 17 October 1783 and was proved 14 July 1784. It mentions the following people: His dear and loving wife Elizabeth, his daughter Ann (married to Edward Asling), and his son Robert. The will mentions property at Fisherton, Notts, and at Appleton Gate in Newark itself. A mixture of Parish Register entries and the IGI help work out this family - namely that John Marris married Elizabeth Clay and that they had three children: Robert, Rosomon and Ann.

The burial of John comes from a pedigree drawn in the 1930s by a researcher called Holden who says that this John was appointed Gaoler & Coroner of Newark on 22 Apr 1756. Given that John's will gives his occupation as Feltmonger, one would need to check a bit further to make sure these are not two separate Johns.

Holden says that the Newark Burial Register says that Elizabeth was the wife of John Marris.

John and Elizabeth had the following children:

- 45. **Thomas Marris** (Robert, Robert, John, Unknown) was born about 1704/1705. He died on 19 Dec 1797. He was buried on 24 Dec 1797 in St Peter, Barton Upon Humber, Lincs.

Thomas married **Elizabeth Ostler** on 12 Oct 1742 in St Peter, Barton Upon Humber, Lincs. Elizabeth was born about 1726/1727. She died on 28 Jan 1800. She was buried on 4 Feb 1800 in St Peter, Barton Upon Humber, Lincs.

The Barker Papers at the Sheffield Archives contain a letter (Ref: Bar.D.674/1a) dated 4 March 1745 from Thomas Marris of Barton upon Humber to Mr Thomas Barker of Bakewell who was Steward for the Duke of Rutland. Thomas Marris writes of the death of his aunt "Dear Mrs Wilkinson of Stamford on Wednesday 19 Feb last past", and lists the legacies given by her will. Thomas Marris says he is the son of the executor of Sarah Wilkinson's will. We can tell from Thomas' signature with the ornate capital "T" that this is our own Thomas Marris of Barton upon Humber (c.1704/05 - 19 Dec 1797). Additional confirmation is a postscript that Thomas added to the letter saying he has been married for three years 12 October last, has one fine boy, Robert, and another coming.

The will of Sarah Wilkinson names Thomas's father as Robert Marris, surgeon.

Thomas writes to John Barker of Bakewell on 17 Dec 1756 (Ref: Bar.D.802, Item 4) concerning a legacy of the will of Sarah Wilkinson. In this letter, Thomas mentions that his parents had both died "about 3 years ago" and that he had had 10 children of which 6 were still living, "4 boys and 2 girls, Robt my Eldest is about 12, Wm the next near 11, Joseph is about 8 & Jno the youngest will be 2 next Xtmas (sic) Day. Jane my Eldest Daughter is turned 3 years & Sarah the youngest is something more than 6 months". In this letter, Thomas Marris also asks John Barker to relay his regards to "Aunt Marris". The signature on this letter is the same as on Bar.D.674/1a above, with the same ornate capital "T".

Thomas Marris made his will (LCC Wills 1798/ii/68, undated) in which he names his wife Elizabeth, sons William, Joseph & Thomas Marris, daughter Jane Lawrence and her husband Mr John Lawrence, and his other daughter Elizabeth Berriman and her husband The Rev. William Berriman. The will was proved on 28 February 1798.

An MI at Barton St Peter, a white marble monument, over a pillar in the nave looking southward, reads as follows:

In memory of Thomas Marris of Barton upon Humber in the county of Lincoln, Gent, who died 19 December 1797, aged 92, and of Elizabeth, his wife, who died 28 January 1800, aged 73, of Sarah, their daughter who died in June 1769, aged 13, of Robert, their eldest son, who died 19 January 1791 aged 46, of Joseph, another of their sons, who died 23 August 1808, aged 58, and of seven of their children who died in infancy, all of whom are interred near this place, and also in memory of John, another of their sons, who was on board the Repulse Frigate, when lost at sea, in the year 1777, he was then in the 22 year of his age.

It is from the above MI that the year of birth of Thomas has been calculated. However, no record of his baptism has been found. We know that his father, Robert Marris, surgeon, was from Newark upon Trent, Notts, but a thorough search of the Newark PRs did not reveal Thomas' baptism.

The Hull Advertiser (March 1, 1800) reported the death of Elizabeth (nee Ostler) as follows:

Lately at Barton, Lincs, Mrs Marris, relict of the late Thomas Marris Esq, attorney at law.

Thomas and Elizabeth had the following children:

 Robert Marris was christened on 15 Nov 1744 in St Peter, Barton Upon Humber, Lincs. He died on 19 Jan 1791. He was buried on 23 Jan 1791 in St Peter, Barton Upon Humber, Lincs.

Robert Marris went up to Cambridge and entered the Church. His entry in Alumni Cantabrigiensis reads follows:

Marris, Robert, College: PETERHOUSE, Entered: Michs. 1763

Died: Jan. 19, 1791

Adm. sizar (age 18) at PETERHOUSE, Apr. 6, 1762. [Eldest] s. of Thomas, Esq., of Barton-on-Humber, Lincs. [and Elizabeth]. School, Beverley. Matric. Michs. 1763; Scholar, 1763. Migrated to Queens', Mar. 10, 1764; B.A. 1766; M.A. 1769; B.D. 1778. Fellow of Queens', 1769-91. V. of Great and Little Eversden, Cambs., 1778-91. Died Jan. 19, 1791, aged 58. M.I. at St Peter's, Barton-on-Humber, Lincs. (T. A. Walker, 322; Monson, Lincs. Church Notes.).

His burial on 23 Jan 1791 is recorded in the Barton on Humber burial register as follows: "The Revd Robert Marris B.D. Senr. F of Queen's Coll: Cantab:".

  - iv. Joseph Marris was christened on 20 Nov 1748 in St Peter, Barton Upon Humber, Lincs. He died on 23 Aug 1808 in St Peter, Barton Upon Humber, Lincs. He was buried on 26 Aug 1808 in St Peter, Barton Upon Humber, Lincs.

Joseph Marris was attorney of the King's Bench and Court of Chancery. The Hull Advertiser (August 27, 1808) reported his death as follows:

On Tuesday last at Barton on Humber aged 59, Joseph Marris Esq, late of Bawtry by whose death the principal part of his property devolves upon his brother Thomas Marris Esq of Barton.

Joseph Marris, Esquire, of Barton on Humber, made his will (PRO Wills 1809 PROB 11/1493) on 5 July 1808 and it was proved 22 February 1809. The will names, among others, the testator's brother William Marris, Doctor, Charlotte Marris (wife of William), the testator's sister Jane Laurence (married to John Laurence), sister Elizabeth Berriman (married to the Rev. William Berriman) and brother Thomas Marris (executor).

- v. **Thomas Marris** was christened on 4 Dec 1749 in St Peter, Barton Upon Humber, Lincs. He was buried on 14 Jul 1750 in St Peter, Barton Upon Humber, Lincs.
- vi. **John Marris** was christened on 9 Mar 1751 in St Peter, Barton Upon Humber, Lincs. He was buried on 14 Feb 1752 in St Peter, Barton Upon Humber, Lincs.
- 55 F vii. **Sarah Marris** was christened on 5 Jul 1752 in St Peter, Barton Upon Humber, Lincs. She was buried on 27 Dec 1752 in St Peter, Barton Upon Humber, Lincs.
- 56 F viii. **Jane Marris** was christened on 12 Nov 1753 in St Peter, Barton Upon Humber, Lincs. She was buried on 9 May 1845 in All Saints, Winteringham, Lincs.

Jane married **John Lawrence** on 12 Apr 1784 in St Peter, Barton Upon Humber, Lincs. John was buried on 18 May 1817 in All Saints, Winteringham, Lincs.

They were married by Jane's brother, Rev. Robert Marris. John Lawrence was of Roxby, Lincs, where they lived after their marriage. They were buried at All Saints, Winteringham, Lincs, he on 18 May 1817, age 81, and she on 9 May 1845, age 91.

Jane Lawrence née Marris made her will (PROB 11/2019/317) on 11 April 1840 and it was proved. 4 June 1845. Her nephew William Marris of Grays Inn was named as sole executor. The will also named her late brother Robert Marris, her

brother Thomas Marris and her numerous nephews & nieces, the children of said Thomas Marris, viz: James Graburn Marris, John Marris, Jane Eyles, Edward Marris, Henry Marris, Frances Elizabeth Marris, Robert Marris, Helen Marris, George Hildyard Marris and Sarah Reid.

57 M ix. John Marris was born on 25 Dec 1754. He was christened on 26 Dec 1754 in St Peter, Barton Upon Humber, Lincs. He died on 27 Oct 1776 in HMS Repulse.

Document Bar.D.802 (Item 4) at the Sheffield Archives (see the above notes against John's father Thomas Marris) gives John's date of birth as Christmas Day 1754. Burke's Landed Gentry (1952) says that John Marris was a lieutenant in the Royal Navy and was lost at sea in HMS Repulse.

The Royal Navy History web site (<a href="http://www.royal-navy.org/hms-repulse-lost-all-hands">http://www.royal-navy.org/hms-repulse-lost-all-hands</a>) records that HMS Repulse was lost with all hands on 27 October 1776. Other references indicate that the loss took place off Bermuda where she foundered in a hurricane.

- x. Sarah Marris was christened on 10 Jun 1756 in St Peter, Barton Upon Humber, Lincs. She died on 22 Jun 1769 in St Peter, Barton Upon Humber, Lincs. She was buried on 3 Aug 1769 in St Peter, Barton Upon Humber, Lincs.
- + 59 M xi. **Thomas Marris** was christened on 21 Dec 1757. He died on 31 Mar 1841.
  - 60 F xii. **Marian Marris** was christened on 11 Jan 1759 in St Peter, Barton Upon Humber, Lincs. She was buried on 1 Feb 1759 in St Peter, Barton Upon Humber, Lincs.
  - 61 F xiii. **Elizabeth Marris** was christened on 29 Oct 1760 in St Peter, Barton Upon Humber, Lincs.

Elizabeth was first baptised privately on 4 Oct 1760 and then publicly at Barton St Peter on 29 Oct 1760.

62 F xiv. **Elizabeth Marris** was christened on 4 Jan 1762 in St Peter, Barton Upon Humber, Lincs. She was buried on 26 Feb 1842 in Saxby, Lincs.

Elizabeth was first baptised privately during Dec 1761 and then publicly at Barton St Peter on 4 Jan 1762. After her marriage to William Berriman, Clerk, they lived at Messingham.

Elizabeth married **Rev. William Berriman** on 27 Mar 1781 in St Peter, Barton Upon Humber, Lincs. Rev. was buried on 23 Jun 1814 in Saxby, Lincs.

John Kirkby (c.1921 - see Kirkby Collection at Lincolnshire Archives) says that Elizabeth died at Barton Feb 1842, aged 80, then a widow, the aunt of Wm Edward Marris of Whitefriargate, Hull. Also that William Berriman was of Saxby.

William Berriman, Rector, was buried at Saxby, Lincs, on June 23 1814, age 63.

The Hull Packet (25 Feb 1842) recorded the death as follows:

Death age 80, Elizabeth, relict of the late Rev William Borriman of Saxby, and aunt of Mr E Marris, Whitefriargate, Hull. [the Mr E Marris referred to was Edward Marris, son of Thomas Marris & Jane née Hildyard.]

Elizabeth Berriman, of Barton, was buried at Saxby, Lincs, on 26 Feb 1842, aged 80.

63 M xv. **Samuel Dixon Marris** was christened on 11 Oct 1765 in St Peter, Barton Upon Humber, Lincs. He was buried on 21 May 1766 in St Peter, Barton Upon Humber, Lincs.

#### Sixth Generation

50. **William Marris** (Thomas, Robert, Robert, John, Unknown) was christened on 29 Apr 1746 in St Peter, Barton Upon Humber, Lincs. He died in May 1823 in London.

William married **Charlotte Wiglesworth** on 22 Dec 1767 in Manton, Lincs. Charlotte died on 23 Feb 1824.

Burke's Landed Gentry (1952) says that William Marris was of Winterton Hall. There are numerous records at the Lincolnshire Archives concerning William Marris of Winterton. Although none of these records has been consulted in detail, the card index alone reveals that he was a surgeon, was involved in all sorts of land transactions, and that his wife was called Charlotte.

The Lincoln, Rutland & Stamford Mercury (Friday 16 April 1790) reported the following:

"Amongst the fortunate proprietors of Lottery tickets this season, is Mr Marris of Winterton in this county, who a few days ago was agreeably surprised at being informed, the ticket of which he held a Half Share, had drawn a £20,000 Prize. He then immediately set off for London where he has had the pleasure to receive £10,000 on demand, as being his share of the Prize."

One assumes that this Mr Marris could have been William or perhaps one of his sons.

The family papers of the late Harold Colquhoun Marris OBE (1883-1966) refer to "Old Houses in Winterton", which says: "In 1790, a resident surgeon (William) Marris won a half lottery share. He went to London to receive the money (£10,000). He had "The Hall", "The Elms" and "Blankney House" built with the money".

The Hull Advertiser (May 23, 1823) ran the following Obit:

Last week, in London, at a very advanced age, William Marris Esq. M.D., of Colchester, Essex, formerly an eminent practioner at Winterton in the County of Lincoln and father of Mr. Marris, Solicitor of Lincoln.

The death of Charlotte Marris née Wigelsworth was reported in the Stamford Mercury (5 March 1824) as follows:

Suddenly on 23 ult Colchester, Essex in the 83rd year of her age, Mrs Marris one of the daughters of the late Thomas Wigelsworth Esq., of Cleatham Hall in this county and the widow of Wm Marris MD late of Winterton whose death was announced in one of our papers in May last, and who were the father and mother of Mr Marris, solicitor of Lincoln.

A will at the PRO (PROB 11/1689) dated 4 February 1824 and proved 31 August 1824 names:

- Charlotte Marris, testatrix, Widow of Colchester, Essex
- William Marris, late husband, formerly of Winterton, Lincs and late of Colchester, Essex
- Charles Wigelsworth of Chatham in the Parish of Manton, Lincs (late father)
- Sarah Ffoster, widow (only surviving daughter) (executrix)
- Walter Bird of Colchester (friend)
- Helen(?) Ffoster (only surviving child of above Sarah)
- Charles Wrinch (witness)
- Joseph Allen, Surgeon, Colchester (witness).

William and Charlotte had the following children:

- + 64 M i. **Charles Marris** was christened on 28 Aug 1770.
  - 65 F ii. Mary Marris was christened on 17 May 1772 in Winterton, Lincs. She died on 7 Feb 1788 in Winterton, Lincs. She was buried on 9 Feb 1788 in Winterton, Lincs.

Burke's Landed Gentry (1952) records the date of Mary's baptism and her death. However, whereas Burke's gives her year of death as 1787 whereas, it was in fact 1788. The Winterton burial register records Mary' parents as William and Charlotte, that father William was an apothecary and that Mary was buried in the church.

- + 66 M iii. **Robert Marris** was christened on 19 May 1774. He died on 30 Dec 1847.
  - 67 F iv. **Sarah Marris** was christened on 7 May 1778 in Winterton, Lincs. Sarah married **Peter Foster** on 19 Apr 1800 in Winterton, Lincs.

The Winterton PRs show that Charles Marris was one of the witnesses at the wedding. Peter was Lieut of 4th (King's Own) Regiment of Foot. He was from St Marylebone Parish.

An LFHS fiche entitled "Lincs Obituary & Records (1800 – 1859)" reads:

April 20, 1800, Lieut. Foster of the 4th (King's Own) Regiment of Foot, married to Miss Sarah Marris, youngest daughter of William Marris Esq. Of Green-Hall, County of Lincoln.

Note: the actual marriage date was 19th April 1800.

- 68 M v. William Marris was christened on 5 Sep 1779 in Winterton, Lincs. He was buried on 21 Sep 1779 in Winterton, Lincs.
- 69 F vi. **Frances Charlotte Marris** was christened on 18 May 1773 in Winterton, Lincs.

Frances married Joseph Dinsdale on 25 Sep 1794 in Winterton, Lincs.

The Winterton marriage register shows that the wedding witnesses were Sarah Marris, James Cookson, Wm Francis & Robt Marris.

70 F vii. Charlotte Marris died on 8 Dec 1804 in Winterton, Lincs.

Charlotte married Robert Wade on 30 Jun 1800 in Winterton, Lincs.

The Winterton PRs show that Charles Marris was one of the witnesses at the wedding. Robert Wade was from Sheffield.

The Hull Packet (Tuesday 18 December 1804) reported the death of Charlotte Wade (née Marris) as follows:

On Saturday fe'nnight, at Winterton, Lincolnshire, in the 29th year of her age, after a long and painful illness, which she bore with true Christian fortitude, Mrs Wade, wife of Mr Wade of Sheffield, and second daughter of William Marris, Esq., late of the former place.

59. Thomas Marris (Thomas, Robert, Robert, John, Unknown) was christened on 21 Dec 1757 in St Peter, Barton Upon Humber, Lincs. He died on 31 Mar 1841 in Duddeston, Birmingham, Warks.

Thomas Marris was the chief partner of the North Lincolnshire Bank which he, along with Joseph Marris and Richard Nicholson, set up in 1790. The bank was situated at Cobb Hall in Barton upon Humber. It failed spectacularly in 1812 causing much local hardship. The bank had a previous high reputation but was brought down by the failure of its London agents Boldero, Lushington & Co to whom it owed £34,000 (something well over £1m in today's money). The North Lincolnshire Bank was unable to raise the necessary liquid funds at short notice and was declared insolvent. This was a personal disaster for both Marris & Nicholson who were declared individually bankrupt as well. Their personal estates were auctioned off to recuperate some of the losses. After the disaster, Thomas Marris moved to Leicester around 1814 and then to Birmingham sometime before 1830.

Thomas married (1) **Helen Graburn** on 13 Jul 1779 in St Peter, Barton Upon Humber, Lincs. Helen died on 4 Jan 1787 in St Peter, Barton Upon Humber, Lincs. She was buried on 8 Jan 1787 in St Peter, Barton Upon Humber, Lincs.

An MI at St Peter's Church, Barton upon Humber records her death as follows: "Helen, the wife of Thomas Marris the younger, gent, who died 4th Jan 1787, aged 31 years, by whom he had 5 children, ? of which died in their infancy and are interred near this place".

Thomas and Helen had the following children:

Thomas married (2) **Jane Hildyard** on 27 Feb 1792 in Barton Upon Humber, Lincs. Jane was born on 27 Feb 1767. She died on 14 Mar 1831 in Birmingham, Warks.

The Hull Advertiser (March 25, 1831) gives her Obit as follows:

On 14th inst at Birmingham, aged 63, Jane the wife of Mr T. Marris of Barton.

Thomas Marris, Gentleman of Aston, Warks, made his will (PRO Wills 1841 PROB 11/1946) on 8 March 1839 and it was proved 25 May 1841. The will names, among others, his daughters Jane Marris, Frances Elizabeth Marris (Executrix) and Helen Marris.

Thomas and Jane had the following children:

76 M vi. **Thomas Marris** was born on 3 Apr 1793. He was christened on 14 Apr 1793 in St Peter, Barton Upon Humber, Lincs. He died on 3 Jul 1823. He was buried on 5 Jul 1823 in St James, Piccadilly, Westminster.

According to an inquest reported in the London Morning Chronicle Thursday 3 July 1823, Thomas Marris committed suicide by razor to throat.

The Salisbury & Winchester Chronicle 18 Aug 1823 recorded the death of "Mr Thomas Marris of London, Solicitor in 30th year of his age and son of Mr Marris, Belgrave, Leicester".

Ellen Marris, Sister, U, 44, born Barton Upon Umber (sic), Lincoln . . . and one servant

John Marris, Gentleman of Plymouth, Devon, made his will (PRO Wills 1855 PROB 11/2206) on 10 July 1841 and it was proved 2 July 1855. The will names, among others, his cousin Henry Hildyard of Winestead, his sister Helen Marris (spinster and Executrix), witness Wm Marris of Grays Inn, and witness Xfr(?) Stevens who was Clerk to Wm Marris. One assumes the first witness was Wm Marris of Marris & Hicks.

We can confirm that this is the correct will because the will of James Graburn Marris (PRO Wills 1853 PROB 11/2172) refers to John Marris of Plymouth, brother.

The GRO Index of Deaths records the death of John Marris in Dec Qtr. 1854 at Plympton Reg. Distr., Devon.

Her mother Jane's death was announced in the Leicester Chronicle (Sat 18 Oct 1851).

81 M xi. **Edward Marris** was christened on 7 Nov 1800 in St Peter, Barton Upon Humber, Lincs. He died on 14 May 1884 in Kingston Upon Hull, Yorks.

Burke's Landed Gentry (1952) records the year of Eliza Ann's death but not the place.

66. **Robert Marris** (William, Thomas, Robert, Robert, John, Unknown) was christened on 19 May 1774 in Winterton, Lincs. He died on 30 Dec 1847 in Lincoln, Lincs.

Burke's Landed Gentry (1952) says that Robert Marris was killed in the hunting field. However, the truth of the matter (see below) was that he died in a field in the snow while drunk!

Robert married **Sarah Pettener** on 24 Apr 1799 in St James, Louth, Lincs. Sarah was christened on 18 Sep 1772 in Louth, Lincs. She died on 26 Mar 1861 in Bloomsbury, Mddx.

Robert & Sarah were married by Licence on 24 Apr 1799. They were Bachelor & Spinster, both of the Parish of Louth. Sarah was baptised at Louth on 18 Sept 1772, the daughter of Samuel Carter Pettener & his wife Sarah.

Robert Marris, Solicitor, was in partnership with John Nicholson at Louth who himself may have been the son of Richard Nicholson who was the partner of Thomas Marris in the North Lincolnshire Bank which failed in 1812. The partnership of Marris & Nicholson ceased practising on becoming insolvent.

Robert Marris was declared personally bankrupt in 1807 and confined to the debtors' prison at Lincoln Castle for seven years. After then being convicted for an assault, he found himself moved to the felons' side of the prison.

The 1841 Census at Brumwith Court, St Michael on the Mount, Lincoln, Lincs, shows:

The decline of Robert Marris was gradual but ultimately fatal. A Public Enquiry into conditions at the prison in 1812 mentioned that Mr Robert Marris had had "an accidental concussion of the brain some years since" and was "occasionally subject to a suspension of recollection, and to violent irritations." Robert Marris died on 30th December 1847. An inquest held at Lincoln the same day said that Robert Marris had been found dead in a field that morning. It was thought he had entered the field and been caught out by a fall of snow. Being intoxicated, he had fallen and fatally injured himself while wandering around in the snow trying to feel his way out.

Burke's Landed Gentry (1952) gives her surname as Martineau whereas the Horkstow marriage entry shows Martinson as does the Barton St Peter register when their daughter Mary Jane was baptised.

Terrace, Mddx), brother John Marris of Plymouth, brother Edward Marris, sister Mary Marris of Birmingham, brother Robert Marris of Birmingham, brother George Marris of Birmingham, sister Sarah(?) Marris of Birmingham, sister Eliza Marris of Yarmouth, sister Helen Marris of Plymouth,

The index of wills at Somerset House shows that Ruth Marris failed to administer the above estate before her own death in 1861. The index entry reads as follows:

Few men have departed this life more generally lamented. He had the rare felicity to enjoy the good will & esteem of a numerous acquaintance for the sociableness of his disposition and urbanity of his manners. Throughout his professional career, the maxims of truth and

justice guided and determined all his transactions, honourable in his dealings, his advice was ever esteemed, the inauspicious emanations of an honest heart which while it disdained to defray, rejoiced at the opportunity to produce the peace and happiness of society. In private life, integrity of heart and purity of principle were predominant features in his character, evening his inflexible adherence to the practice of every virtue that could possibly ennoble the Christian and the man".

The marriage of William Marris and Mary Ann Acocks on 28 Sep 1843 at St James, Paddington was reported in the London Standard Saturday 30 Sep 1843.

William died in Hastings on 19th Oct 1845. His death was reported in the Leicester Chronicle (Sat 1st Nov 1845) and Yorkshire Gazette (Sat 25th Oct 1845). The Hull Advertiser (October 24, 1845) also reported the death, as follows:
